### **Prince Edward Island Court of Appeal, Supreme Court and Provincial Court**

**December 9, 2021**

This notice is to provide additional information and clarification on court operations at the Charlottetown courthouse facilities. Two Charlottetown staff members tested positive for COVID-19 and therefore the courts have operated on a modified basis over the last few days. Generally, matters have proceeded virtually or have been adjourned.

The Chief Public Health Office has recently identified the courthouse facilities located at 42 Water Street, Charlottetown (Court of Appeal and Supreme Court) and 3 Harbourside Access Road, Charlottetown (Provincial Court) as public exposure sites for the following dates: Thursday December 2, Friday December 3 and Monday December 6. Given the current situation, and out of an abundance of caution, the courts in Charlottetown will continue to operate on a modified basis at this time. Matters will generally not proceed in person, but rather will proceed virtually or will be adjourned. However, emergency, urgent or essential matters may proceed in person.

The courts are attempting to reach out to parties directly in relation to scheduled matters. However, any questions may be directed to the following:

Regarding access to the court proceedings during the COVID-19 pandemic**

**Prince Edward Island Court of Appeal, Supreme Court and Provincial Court**

**February 19, 2021**

Since March 2020, the Prince Edward Island courts have been operating with restrictions on public access to court proceedings. The courts seek to comply with changing CPHO health care guidelines during the COVID-19 pandemic. The purpose of managing access is to ensure the safety of participants and provide ability to carry out contact tracing.

The courts respect the open court principle. This involves broad access to court proceedings by members of the public and media. Restrictions on access due to COVID are limited to those considered necessary to ensure a safe environment for all persons who are necessarily involved in the court process. Since March, courts administration has permitted fewer individuals into the courthouses and courtrooms and has required participants to provide personal contact information in order to accommodate CPHO COVID requirements.

For this purpose, the courts adopted a process whereby when a party, witness, lawyer or other person who is to attend court is to advise the court clerk in advance the names and contact information for all individuals who will attend court.

However, while most participants have tried to be compliant, some gaps are being experienced so that courts do not always receive requests and contact information in advance of court proceedings. This results in log-jams at court entrances. Delays are experienced by all, to await Sheriff screening and court approval for attendance.

Therefore, for clarification and going forward, if a party or lawyer is aware that other persons may plan or wish to attend court proceedings – such as a witness or support person or other member of the public or the media – the party or lawyer is requested to inform court administration and seek prior approval. They should indicate the number and names of individuals, contact information, and their role in the proceeding. This will enable court administration or the presiding judge, as applicable, to make a determination regarding access for additional persons and safe accommodation for all.

The courts strive to ensure that CPHO and court guidelines regarding COVID-19 are followed in order to minimize health risks for all persons who attend at the courthouses and court proceedings.

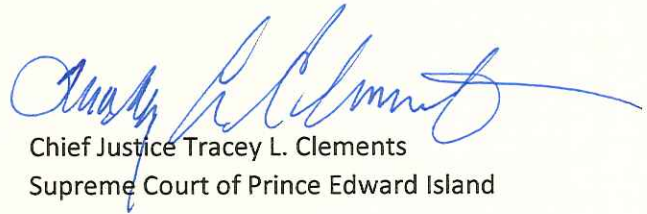
